MESSAGE FROM OUR PRESIDENT

September 17 was snowy and rainy but 35 to 40 club members came to Chief Joe and had a great time. We moved over three cords of firewood to the basement. Another crew had split the wood the previous week. We also piled a little brush and gave the Hut a thorough cleaning. We had a short business meeting where we decided to purchase the 2002 Chevrolet Silverado from Karl Tyler Chevrolet in Missoula. We had about nine proposals and the truck committee narrowed those to two and then took those two pickups to the Cheese Factory garage in Corvallis. After a thorough inspection the choice was quite easy and we are the owner of a very nice pickup that will meet our needs for many years. BEAVERHEAD-DEERLODGE FOREST PLAN REVISION By Art Seifert

Since 2002 the USFS has been working on updating the 19 year old management plans for the Beaverhead and Deerlodge National Forests. In June, the USFS released for public comment a draft Environmental Impact Statement (DEIS) and a draft Management Plan (sometimes referred to as the "Preferred Alternative") for the now combined Beaverhead-Deerlodge National Forest. The "Preferred Alternative" is one of five courses of action that are on the table. The five alternatives are:

- 1. Continue the 1986 and 1987 plans (in effect, the "No Action" plan.)
- 2. The USFS "2003 Proposed Action" (in effect, a "Trial Balloon".)
- 3. Alternative 3: Emphasize primitive recreation / little development of natural resources (in effect, the "Let Nature Take Its Course" plan.)
- 4. Alternative 4: Emphasize motorized recreation and active development of natural resources (I call this the "ATV / Snowmobile" plan.)
- 5. Alternative 5: The USFS has designated this the "Preferred Alternative." It includes a mix of uses, including both motorized and non-motorized recreation.

The Regional Forester has the responsibility and the authority to decide what revisions to make to the Forest Plan, but public comments are an important influence on that decision. As members of the BRXC Ski Club and beneficiaries of certain of the Beaverhead-Deerlodge natural resources, it is in our interest, individually and collectively, to assert our interest through the public comment process. In its announcement of the Forest Plan revision the USFS has (I think, pointedly) stated:

The draft plan and DEIS also deal with the following subjects:

Recreation (Unregulated Motorized Use): Currently 41% (1,385,800 acres) of the forest is without travel management direction and 84% (2,839,200 acres) is open to snowmobiles during the winter. Winter use was not addressed in the current forest plans. Use and technology have increased dramatically on the forest in these 19 years. Currently, all recommended wilderness areas allow motorized winter and summer use. The draft plan calls for prohibiting motorized use in recommended wilderness and in other areas, some of which have little use.

Subj: Response to invitation for public comment on the Draft Forest Plan for the Beaverhead-

Deerlodge National Forest.

I want to comment on that portion of the Draft Forest Plan that deals with the "Big Hole Landscape" / "Trail Creek Niche," an area that includes the Chief Joseph Cross-Country Ski Area.

The description of the Trail Creek Niche (p. 95) correctly sets the context for management objectives as uniqueness. This area is indeed unique due to the presence of the nationally designated trails (Continental Divide National Scenic Trail (CDNSC); Lewis and Clark National Historic Trail (LCNHT); Nez Perce National Historic Trail (NPNHT) and also the presence or proximity of the USFS rental cabins Hogan, May Creek and Gordon Reese.

I support the Management Emphasis priorities (p. 95), especially "Non-motorized areas for quiet recreation." As a member of the Bitterroot Cross-Country Ski Club I have personally expended time and (through the Club) money in helping to create and maintain the Chief Joseph Ski Area and the Gordon Reese cabin. I feel I have a stake in the preservation of the character and quality of this recreational area.

However, under the heading, "Objectives in addition to Forestwide Objectives" I do not believe that management of the May Creek National Recreation Trail as a winter snowmobile route is consistent with the rest of the Management Emphasis.

As I interpret the Trail Creek Management Area Map (p. 94) the Draft Plan would make the entire Trail Creek area non-motorized in winter, but in the summer, the area encompassed by the CDNST, Montana Highway 43, and the LCNHT would be open to motorized travel. I think that is a mistake. Motorized travel is inconsistent with the CDNST and LCNHT. The USFS, as well as the BRXC Ski Club and non-club members who have contributed to the ski area infrastructure including the Gordon Reese cabin have made a considerable investment that would be subjected to an increased risk of theft and vandalism. Summer motorized travel would complicate the USFS's administrative and law enforcement responsibilities and would likely create additional environmental degradation such as soils erosion on roads and trails not engineered to handle it. The problem of logistical support for the Gordon Reese cabin can easily be handled by amending the first paragraph under the heading, "Standards in addition to Forestwide Standards to read, "The Chief Joseph ski area is closed to snowmobiling as a recreation use; however, snowmobiles in winter and wheeled, motorized vehicles in summer may be used for grooming and other administrative activities." I urge the USFS to close the entire Trail Creek Niche to motorized travel year around. I believe that action is essential to achieve the results sought by the Management Emphasis.
